2013/0810(NLE) - 17/12/2013 - Final act

PURPOSE: to appoint five members of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision 2013/772/EC appointing five members of the Court of Auditors.

CONTENT: the terms of office of Mr Gijs DE VRIES, Mr Henri GRETHEN, Mr Michel CRETIN, Mr Ioannis SARMAS and Mr David BOSTOCK are due to expire on 31 December 2013.

New appointments have therefore been made to replace these members.

The Council has appointed, amongst others, **Mr Alex BRENNINKMEIJER** (NL) for the period from 1 January 2014 to 31 December 2019.

2013/0810(NLE) - 11/12/2013 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 526 votes to 48, with 42 abstentions, a decision in which it delivered a favourable opinion on the Council's nomination of Alex Brenninkmeijer (NL) as a Member of the Court of Auditors after having agreed that his credentials fulfilled the requirements laid down in Article 286(1) of the Treaty on the Functioning of the European Union.
