## European Banking Authority (EBA): extension of the term of office of the Chairperson

2015/0903(NLE) - 16/12/2015 - Text adopted by Parliament, 1st reading/single reading

The European Parliament approved by 532 votes to 101, with 55 abstentions, the proposal for the **extension of the term of office of Andrea Enria** as Chairperson of the [European Banking Authority](#) (EBA) by another five-year term.

To recall, on 8 September 2015, the Board of Supervisors of the EBA proposed to extend the term of office of Andrea Enria, the incumbent Chairperson of the EBA, by another five-year term, and informed the European Parliament accordingly.

On 17 November 2015, the Committee on Economic and Monetary Affairs held a hearing with Andrea Enria at which he made an opening statement and then responded to questions from the members of the Committee.
