Court of Auditors: appointment of a Belgian member

2017/0812(NLE) - 26/10/2017 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Budgetary Control adopted the report by Indrek TARAND (Greens/EFA, EE) on the proposed nomination of **Karel Pinxten** (BE) as a member of the Court of Auditors.

The committee evaluated the credentials of the nominee proposed by the Council, in particular in view of the requirements laid down in Article 286(1) of the Treaty on the Functioning of the European Union (TFEU). It then proceeded with the hearing of the candidate at its meeting of 19 October 2017.

Members called on the European Parliament to deliver **a negative opinion** on the Council's nomination of Karel Pinxten as a Member of the Court of Auditors.

The European Parliament voted (284 votes to 310, with 81 abstentions) to **deliver a negative opinion** on the Council's nomination of **Karel Pinxten** as a Member of the Court of Auditors.
