Court of Auditors: appointment of a Bulgarian member

The European Parliament **voted favourably** (568 votes to 61, with 37 abstentions) on the Council's nomination of **Iliana Ivanova** as a Member of the Court of Auditors.

The Committee on Budgetary Control adopted the report by Indrek TARAND (Greens/EFA, EE) on the proposed nomination of **Iliana Ivanova** (BG) as a member of the Court of Auditors.

The committee evaluated the credentials of the nominee proposed by the Council, in particular in view of the requirements laid down in Article 286(1) of the Treaty on the Functioning of the European Union (TFEU). It then proceeded with the hearing of the candidate at its meeting of 26 October 2017.

Members called on the European Parliament to deliver a **favourable opinion** on the Council's nomination of Iliana Ivanova as a Member of the Court of Auditors.
