Court of Auditors: appointment of an Irish member

2017/0820(NLE) - 17/01/2018 - Text adopted by Parliament, 1st reading/single reading

The European Parliament delivered a **favourable opinion** (592 votes to 56, with 35 abstentions) on the proposal of the Council to appoint **Tony James Murphy** member of the Court of Auditors. It called on the Member States to pay attention to, and if possible take inspiration from, the open competition model used by Ireland when selecting their nominees.
