Partial renewal of the Members of the Court of Auditors - PL nominee

2020/0806(NLE) - 15/12/2020 - Text adopted by Parliament, 1st reading/single reading

The European Parliament decided by 156 votes to 536, with 3 abstentions, to deliver an unfavourable opinion on the Council's proposal to nominate Marek Opiola as a Member of the Court of Auditors.

Marek Opiola is the current Vice-President of the Polish Supreme Audit Office.

By letter of 5 November 2020, the Council consulted the European Parliament on the nomination of Marek Opiola as a member of the Court of Auditors. After hearing Marek Opiola on 7 December, the members of the Committee on Budgetary Control recommended the Parliament not to approve his candidacy.
