# Mobilisation of the European Union Solidarity Fund: assistance to Romania and Italy in relation to natural disasters in 2022 and to Türkiye in relation to the earthquakes in February 2023

2023/0297(BUD) - 23/08/2023 - Non-legislative basic document

**PURPOSE:** to mobilise the European Union Solidarity Fund to assist Romania and Italy following natural disasters in 2022, and Turkey following earthquakes in February 2023.

**PROPOSED ACT:** Decision of the European Parliament and of the Council.

**BACKGROUND:** the European Union Solidarity Fund, set up by Council Regulation (EC) No 2012/2002, aims to enable the Union to respond in a rapid, efficient and flexible manner to emergency situations in order to show solidarity with the population of regions struck by major or regional natural disasters or major public health emergency.

- On 6 September 2022, **Romania** submitted an application to mobilise the Fund, following the drought in the summer of 2022. The Romanian authorities estimate the total direct damage caused by the disaster at EUR 1.31 billion. Romania estimated the cost of operations eligible at EUR 34.69 million and presented it broken down by type of operation. The largest share of the cost of emergency operations (over EUR 22.35 million) concerns rescue services, including firefighting actions, supply of water to the population and to the affected agricultural fields.

- On 8 December 2022, **Italy** submitted an application to mobilise the Fund, following the flood in the Marche Region in September 2022. The Italian authorities estimate the total direct damage caused by the disaster at EUR 837.56 million. Italy estimated the cost of operations eligible at EUR 169.07 million and presented it broken down by type of operation. The largest share of the cost of emergency operations (over EUR 67.57 million) concerns temporary accommodation and rescue services.

- On 20 April 2023, **Türkiye** submitted an application to mobilise the Fund, following the earthquakes in February 2023. The Turkish authorities estimate the total direct damage caused by the disaster at EUR 81.7 billion. Türkiye estimated the cost of operations eligible at EUR 15.109 billion and presented it broken down by type of operation. The largest share of the cost of emergency operations (EUR 9.1 billion) concerns restoration to working order of infrastructure in the fields of health, education, transportation, and others.

The above-mentioned applications meet the conditions for providing a financial contribution from the Fund.

**CONTENT:** this proposed decision covers the mobilisation of the European Union Solidarity Fund (EUSF) in accordance with Council Regulation (EC) No 2012/2002 for an amount of EUR 454 835 030 to provide assistance to Romania and Italy in relation to the natural disasters that took place in these countries in 2022 and to Türkiye in relation to the earthquakes in February 2023.

For the general budget of the Union for the financial year 2023, the European Union Solidarity Fund will be mobilised as follows in commitment and payment appropriations in relation to natural disasters:

## Mobilisation of the European Union Solidarity Fund: assistance to Romania and Italy in relation to natural disasters in 2022 and to Türkiye in relation to the earthquakes in February 2023

2023/0297(BUD) - 04/10/2023 - Budgetary text adopted by Parliament

The European Parliament adopted by 593 votes to 11, with 22 abstentions, a resolution on the proposal for a decision of the European Parliament and of the Council on the mobilisation of the EU Solidarity Fund to assist Romania and Italy following natural disasters in 2022 and Turkey following earthquakes in February 2023.

Parliament approved the decision to mobilise, within the framework of the general budget of the Union for the financial year 2023, the following amounts from the European Union Solidarity Fund in connection with natural disasters:

- **EUR 33 895 935 for Romania** in connection with the drought in summer 2022;
- **EUR 20 939 095 for Italy** in connection with the floods in the Marche region in September 2022;
- **EUR 400 000 000 to Turkey** in connection with the earthquakes in February 2023.

Parliament welcomed this decision as a concrete and visible expression of the Union's solidarity with its citizens and the regions in Romania, Italy and Turkey affected by the earthquakes. It reiterated the importance of **informing the public** of the tangible benefits of the European Union Solidarity Fund (EUSF).

Stressing that extreme weather events will increase in frequency and intensity as a result of climate change, and that the EUSF is only a curative instrument, Members called on the EU to **redouble its efforts to combat climate change** both within the Union and globally.

The Solidarity and Emergency Aid Reserve (SEAR) is constantly exhausted and does therefore not enough to compensate the consequences of man-made and natural disasters particularly disasters related to climate change. Parliament reiterated that the available resources for EUSF should be increased substantially as part of the mid-term revision of the multiannual financial framework and urged the Commission to **increase the budget of the Solidarity and Emergency Aid Reserve (SEAR)** and to substantially reinforce the annual budget of the EUSF.

The Commission is urged to come forward with a model for **faster and timely mobilisation of the EUSF** including the treatment of the applications, so as to allow the relevant authorities to address the restoration needs as soon as possible. It stressed the urgent need to release financial assistance through the EUSF to ensure that support can reach the affected regions in a timely manner and provide the necessary assistance for the operations concerned, as requested by the Member States, such as for infrastructure rehabilitation, rescue services, including firefighting actions, restoration of the affected agricultural areas and provision of water.
