Court of Auditors: appointment of an Italian member

2024/0801(NLE) - 16/01/2024 - Legislative proposal

PURPOSE: to appoint an Italian Member of the Court of Auditors.

PROPOSED ACT: Council Decision.

CONTENT: under Article 247, paragraph 3, of the EC Treaty and Article 160b of the EAEC, Members of the Court of Auditors are appointed by the Council, acting by a qualified majority after having consulted the European Parliament.

Given that the term of office of Mr Pietro Russo, appointed as a member of the European Court of Auditors on 1 March 2018 upon his nomination by Italy, will expire on 29 February 2024, the Italian government has proposed Mr Carlo Alberto Manfredi Selvaggi as a member of the European Court of Auditors.

Consequently, this proposal aims to inform the European Parliament about the nomination of Mr Carlo Alberto Manfredi Selvaggi, an accounting judge who is a president of section and has experience in relations with the European Union in carrying out his professional activity.

Court of Auditors: appointment of an Italian member

2024/0801(NLE) - 14/03/2024 - Text adopted by Parliament, 1st reading/single reading

The European Parliament decided by 316 votes to 186, with 31 abstentions, to deliver a favourable opinion on the Council's nomination of Carlo Alberto Manfredi Selvaggi (Italian candidate) as a Member of the Court of Auditors.

By letter of 17 January 2024, the Council consulted Parliament on the nomination of Carlo Alberto Manfredi Selvaggi as a Member of the Court of Auditors.

Parliament's Committee on Budgetary Control then proceeded to evaluate Carlo Alberto Manfredi Selvaggi's credentials. In carrying out that evaluation, the committee received a curriculum vitae from Carlo Alberto Manfredi Selvaggi, as well as the replies to the written questionnaire that he had been sent.

The committee subsequently held a hearing with Carlo Alberto Manfredi Selvaggi on 22 February 2024, at which he made an opening statement and then answered questions put by the members of the committee.
