Decision on the number and numerical strength of interparliamentary delegations

The European Parliament decided to set the number of interparliamentary delegations, their regional groupings and their numerical strength, as follows:

Europe, Western Balkans and Türkiye

Parliament decided that the delegation bureaux may consist of up to two vice-chairs, with the exception of the bureaux of delegations to multilateral assemblies, for which the delegation bureaux should correspond to the number of Parliament's representatives in the respective bureau of those multilateral assemblies.
