Summary

# Certain corporate sustainability reporting and due diligence requirements (Omnibus I)

2025/0045(COD) - 26/02/2025 - Legislative proposal

PURPOSE : to simplify the rules in the field of sustainability reporting and sustainability due diligence requirements ('omnibus simplification package').

PROPOSED ACT: Directive of the European Parliament and of the Council.

ROLE OF THE EUROPEAN PARLIAMENT: the European Parliament decides in accordance with the ordinary legislative procedure and on an equal footing with the Council.

BACKGROUND: following up on the Draghi report on the future of European competitiveness, the Commission confirmed in its Communication 'A Compass for EU Competitiveness' that it would propose a first '**omnibus package on simplification**' that would include far-reaching simplification in the areas of sustainability disclosures in the financial services sector, sustainability due diligence and taxonomy. In its February 2025 Communication 'A Simpler, Faster Europe', the Commission set out the vision for an implementation and **simplification** agenda that delivers rapid and visible improvements for citizens and businesses on the ground.

In the context of the Commission's commitment to reduce reporting burdens and enhance competitiveness, it is necessary to amend Directives 2006/43/EC (Audit Directive), 2013/34/EU (Accounting Directive), (EU) 2022/2464 (Corporate Sustainability Reporting Directive, the 'CSRD') and (EU) 2024/1760 (Corporate Sustainability Due Diligence Directive, the 'CSDDD'), while maintaining the strategic objectives of the European Green Deal and the Sustainable Finance Action Plan.

Alongside this proposal, the Commission is presenting a separate [legislative proposal](#) aimed at postponing the entry into force of the CSDDD and certain provisions of the CSRD.

CONTENT: this proposal for an omnibus directive amends the provisions of the Audit Directive, the Accounting Directive, the Corporate Sustainability Reporting Directive (CSRD), and the Corporate Sustainability Due Diligence Directive (CSDDD). These directives set out complementary reporting and behavioural duties in the area of sustainability.

This proposal aims to reduce the reporting burden and to limit the trickle down of obligations on smaller companies. Key measures include the following:

- to reduce the number of undertakings subject to sustainability reporting obligations by approximately 80%, excluding large companies with up to 1 000 employees (i.e., some second wave undertakings and some first wave undertakings) and listed SMEs (i.e., all third-wave companies). The reporting requirements would only apply to large companies with an average of more than 1 000 employees and a turnover of more than EUR 50 million or a balance sheet of more than EUR 25 million);
- to introduce, for companies not subject to sustainability reporting requirements, of a **proportionate standard for voluntary use**, based on the voluntary standard for SMEs developed by EFRAG;
- to ensure that sustainability reporting requirements on large companies do not burden smaller companies in their value chains. The value-chain cap would be **extended and strengthened** and would protect all undertakings with up to 1000 employees rather than just SMEs as is currently the case.
- the abandonment of sector-specific reporting standards, which would avoid an increase in the number of prescribed data points that companies would have to report;
- the impossibility of moving from a limited assurance requirement to a reasonable assurance requirement, so as to clarify that the insurance costs borne by the companies concerned will not be increased in the future;
- to publish **assurance guidelines** by 2026, instead of imposing a requirement to adopt sustainability assurance standards;
- to reduce the burden of the **EU Taxonomy reporting obligations** and limit it to the largest companies, while keeping the possibility to report **voluntarily** for the other large companies within the future scope of the CSRD. This is expected to deliver significant cost savings for smaller companies, while allowing businesses that wish to access sustainable finance to continue that reporting;
- to introduce the option of reporting on activities that are **partially aligned with the EU Taxonomy**, fostering a gradual environmental transition of activities over time, in line with the aim to scale up transition finance to help companies on their path towards sustainability;
- to introduce simplifications to the most complex "**Do no Significant harm**" (DNSH) criteria for pollution prevention and control related to the use and presence of chemicals that apply horizontally to all economic sectors under the EU Taxonomy – as a first step in revising and simplifying all such DNSH criteria;
- to adjust, among others, the main Taxonomy-based key performance indicator for banks, the Green Asset Ratio (GAR).

Furthermore, the Commission will adopt a [proposal](#) to amend the **Carbon Border Adjustment Mechanism** (CBAM) as part of the same omnibus simplification package.

# Certain corporate sustainability reporting and due diligence requirements (Omnibus I)

2025/0045(COD) - 17/10/2025 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Legal Affairs adopted the report by Jörgen WARBORN (EPP, SE) on the proposal for a directive of the European Parliament and of the Council amending Directives 2006/43/EC, 2013/34/EU, (EU) 2022/2464 and (EU) 2024/1760 as regards certain corporate sustainability reporting and due diligence requirements.

The committee responsible recommended that the European Parliament's position adopted at first reading under the ordinary legislative procedure should amend the proposal as follows:

## ***Due diligence only for large companies***

To reduce the reporting burden on undertakings, the obligation to prepare and publish a sustainability statement at individual level should be reduced to **undertakings with an average of more than 1000 employees** and a **net turnover of EUR 450 000 000** during the financial year. It should be possible to exempt ultimate parent undertakings which are financial **holding** undertakings not involved in management activities from complying with reporting obligations.

For companies no longer covered by the rules, reporting would be **voluntary**, in accordance with the Commission's guidelines. To prevent large companies from shifting their reporting obligations onto their smaller trading partners, the latter would not be permitted to request information beyond the voluntary standards.

## ***Voluntary Guidelines***

Following consultation with relevant stakeholders, the Commission should develop **voluntary sector-specific guidelines** to assist companies assess their risks, opportunities and impacts in specific sectors, to facilitate the application of mandatory European sustainability reporting standards (ESRS) in a given sector, to identify sustainability issues that may be important for a specific sector and to reduce the reporting burden.

## ***Risk-based approach***

The reporting company should adopt an approach that prioritises efforts to gather information on high-risk impacts and sustainability issues commonly associated with its sector. Instead of systematically asking for information required for their due diligence assessments from their business partners, Members called on the companies to adopt a **risk-based approach**, whereby they only ask for the necessary information where there is a prospect of an **adverse impact** in their business partners' activities. In the case of firms outside the scope of the rules, this would be possible only as a **last resort**. Companies would still be required to prepare a transition plan for climate change mitigation, which aim to ensure, through reasonable efforts, compatibility of the business model and of the strategy of the company with the transition to a sustainable economy and with the limiting of global warming in line with the Paris Agreement.

## ***Corporate due diligence on sustainability***

Directive (EU) 2024/1760 on corporate due diligence regarding sustainability, laying down rules concerning companies' obligations regarding adverse human rights impacts and adverse environmental impacts, should apply to (i) companies with an average of **over 5 000 employees** and a net worldwide turnover of over **EUR 1.5 billion** in the last financial year and (ii) companies with a net turnover of over EUR 1.5 billion in the Union in the financial year preceding the last financial year .

## ***Digital portal***

To facilitate compliance by companies with reporting and due diligence obligations under Union law, and to enhance the accessibility and usability of sustainability-related information, the Commission should establish a **dedicated digital reporting portal**. That portal should serve as a **one-stop shop**, providing companies, free of charge, with tailored access to templates, guidelines, reporting requirements, including voluntary tools, and information on funding and tendering opportunities.

## ***Penalties***

Businesses should be liable for damages caused by breaches of due diligence obligations under national law, rather than at the EU level. The maximum fine level for offending companies would be at 5% of their global turnover. Moreover, to harmonise enforcement practices across the Union, the Commission, in collaboration with the Member States, should develop guidelines to assist supervisory authorities in determining the level of penalties.

# Certain corporate sustainability reporting and due diligence requirements (Omnibus I)

2025/0045(COD) - 16/12/2025 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 428 votes to 218, with 17 abstentions, a legislative resolution on the proposal for a directive of the European Parliament and of the Council amending Directives 2006/43/EC, 2013/34/EU, (EU) 2022/2464 and (EU) 2024/1760 as regards certain corporate sustainability reporting and due diligence requirements.

The position adopted by the European Parliament at first reading amends the proposal as follows:

### ***Due diligence only for large undertakings***

To reduce the reporting burden on undertakings and to achieve the objectives of reporting in a more proportionate way, the obligation to prepare and publish sustainability reporting at individual level should be reduced to undertakings with a net turnover exceeding **EUR 450 million** and an average of more than **1 000 employees** during the financial year. Undertakings, groups and issuers below this threshold remain free to carry out voluntary sustainability reporting.

The rules will also apply to **non-EU companies** with net turnover in the EU of over EUR 450 million and to their subsidiaries and branches generating turnover higher than EUR 200 million in the EU.

### ***Protection for small and medium-sized enterprises***

There is evidence that undertakings in the value-chain, including small and medium-sized enterprises, are receiving disproportionate requests for information from reporting undertakings. Therefore, the amended text introduces protections for undertakings in the value chain that do not exceed **the average of 1 000 employees during the financial year** to limit the burden for those undertakings ('protected undertakings'). Thus, companies required to prepare sustainability reporting will not shift that responsibility to their smaller business partners. Firms with fewer than 1,000 employees will not have to provide information to their bigger business partners beyond what is included in the voluntary reporting standards.

### ***Identifying and assessing actual and potential adverse impacts***

Member States should ensure that companies take appropriate measures to identify and assess actual and potential adverse impacts arising from their own operations or those of their subsidiaries and, where related to their chains of activities, those of their business partners. As part of this obligation, companies must take appropriate measures to:

- carry out a **scoping exercise**, based solely on reasonably available information, to identify general areas across their own operations, those of their subsidiaries and, where related to their chains of activities, those of their business partners where adverse impacts are most likely to occur and to be most severe;
- based on the results of the scoping exercise, carry out an **in-depth assessment** in the areas where adverse impacts were identified to be most likely to occur and most severe. In the case of business partners with fewer than **5000 employees**, companies should request information only when the information cannot reasonably be obtained by other means such as from information they have or other sources.

### ***Corporate sustainability due diligence***

Directive (EU) 2024/1760 on corporate sustainability due diligence, laying down rules concerning companies' obligations regarding adverse human rights impacts and adverse environmental impacts, will apply (i) to companies with an average of over **5 000 employees** and a worldwide net turnover of more than **EUR 1.5 billion** in the last financial year and (ii) to companies with a net turnover of more than EUR 1.5 billion in the Union in the financial year preceding the last financial year.

The directive on the due diligence will apply from 26 July 2029 for all companies concerned.

### ***Civil liability and sanctions***

Businesses will be liable at the national level (rather than EU level) for failures to apply the rules correctly and could face fines of up to **3%** of the firm's net worldwide turnover with the Commission expected to publish the necessary guidelines in this regard.

### ***Digital portal***

The Commission will provide for a dedicated portal through which undertakings may access information, guidance and support, including relevant templates and guidance, with regard to the mandatory and voluntary sustainability reporting framework referred to in this Directive. The portal will be interconnected with online support measures provided by Member States, where they exist, to take account of national contexts.

## **Certain corporate sustainability reporting and due diligence requirements (Omnibus I)**

2025/0045(COD) - 26/02/2026 - Final act

PURPOSE: to simplify, for companies, sustainability reporting and due diligence requirements to boost EU competitiveness.

LEGISLATIVE ACT: Directive (EU) 2026/470 of the European Parliament and of the Council amending Directives 2006/43/EC, 2013/34/EU, (EU) 2022/2464 and (EU) 2024/1760 as regards certain corporate sustainability reporting requirements and certain corporate sustainability due diligence requirements.

CONTENT: this **omnibus directive** amends and simplifies the Audit Directive, the Accounting Directive, the Corporate Sustainability Reporting Directive (CSRD), and the Corporate Sustainability Due Diligence Directive (CS3D) by **reducing the burden of reporting obligations** and limiting the trickle-down effect of these obligations on small businesses.

### ***Corporate sustainability reporting directive (CSRD)***

To reduce the reporting burden on undertakings, the obligation to prepare and publish sustainability reporting at individual level should be reduced to undertakings with a net turnover **exceeding EUR 450 million** and an average of more than **1 000 employees** during the financial year. The rules will also apply to non-EU companies with net turnover in the EU of over EUR 450 million and to their subsidiaries and branches generating turnover higher than EUR 200 million in the EU.

The amending directive also provides for a **transition exemption** for companies that had to start reporting from financial year 2024 (the so-called 'wave one' companies) falling out of scope for 2025 and 2026. It also includes an exemption for certain EU and non-EU financial holding companies from consolidated reporting.

### ***Protection for small and medium-sized enterprises (protected enterprises)***

The directive aims to protect SMEs by **limiting excessive information requests** from large companies. Companies are also supposed to base their efforts on reasonably available information, which will reduce the trickle-down effect of information requests on smaller business partners. Companies with fewer than 1 000 employees will not have to provide information to their bigger business partners beyond what is included in the **voluntary reporting standards**.

### ***Inventory and assessment of actual and potential negative impacts***

The directive requires companies to identify and assess the negative impacts (actual or potential) of their activities, those of their subsidiaries, and their business partners. Companies will be able to focus on the areas of their supply chains where actual and potential negative impacts **are most likely to occur**. They should:

(i) carry out a **scoping exercise, based solely on reasonably available information**, to identify general areas across their own operations, those of their subsidiaries and, where related to their chains of activities, those of their business partners where adverse impacts are most likely to occur and to be most severe;

(ii) carry out an **in-depth assessment** in the areas where adverse impacts were identified to be most likely to occur and **most severe**. Where a company has identified adverse impacts that are equally likely or equally severe in several areas, that company should be able to prioritise assessing adverse impacts which involve direct business partners.

### ***EU Directive 2024/1760 on corporate sustainability due diligence (CS3D)***

The CSRD's scope is narrowed. The Directive will apply to companies: (i) with an average of **over 5 000 employees** and a worldwide net turnover of more than **EUR 1.5 billion** in the last financial year and (ii) with a net turnover of more than EUR 1.5 billion in the Union in the financial year preceding the last financial year.

The amending directive postpones the CS3D's transposition deadline by Member States into national law by another year, to 26 July 2028. Companies will have to comply with the new measures by **July 2029**.

### ***Civil liability and sanctions***

Businesses will be liable at a national level (rather than EU level) for failure to apply the rules correctly and could face fines of up to a maximum cap of **3%** of the company's net worldwide turnover, with the Commission issuing the necessary guidelines in this regard.

## **Certain corporate sustainability reporting and due diligence requirements (Omnibus I)**

2025/0045(COD) - 13/11/2025 - Text adopted by Parliament, partial vote at 1st reading/single reading

The European Parliament adopted by 382 votes to 249, with 13 abstentions, **amendments** to the proposal for a directive of the European Parliament and of the Council amending Directives 2006/43/EC, 2013/34/EU, (EU) 2022/2464 and (EU) 2024/1760 as regards certain corporate sustainability reporting and due diligence requirements.

The issue has been referred back to the committee responsible for interinstitutional negotiations.

### ***Due diligence only for large companies***

To reduce the reporting burden on companies, the obligation to prepare and publish an individual sustainability statement should be limited to companies with an average **of more than 1 000 employees** and net sales of **EUR 450 million or more** during the financial year. It should be possible to exempt ultimate parent undertakings which are financial holding undertakings not involved in management activities from complying with reporting obligations.

For companies no longer bound by rules, reporting would be **voluntary**, in accordance with the Commission's guidelines. Smaller companies would be protected from the reporting requirements of their large business partners, which would not be allowed to request more information than what is set out in the voluntary standards.

The reporting obligations should not require a company to disclose information on intellectual capital, **intellectual property** or know-how, business information or technological information which constitutes trade secrets.

#### ***Voluntary guidelines***

Following consultation with relevant stakeholders, the Commission should develop voluntary sector-specific guidelines to **assist companies** assess their risks, opportunities and impacts in specific sectors, to facilitate the application of mandatory European sustainability reporting standards (ESRS) in a given sector, to identify sustainability issues that may be important for a specific sector and to reduce the reporting burden.

#### ***Risk-based approach***

The reporting undertaking should adopt a risk-based approach, prioritising efforts to gather information on **high-risk impacts** and sustainability issues commonly associated with its sector.

When it comes to defining the value chain for identifying adverse impacts, large companies should not seek information from their trading partners, but **rely solely on information that is already reasonably available** (public information, information from research, or information obtained through prior cooperation). According to Members, it will only be possible to request information from trading partners when, based on a risk-based approach, such information is necessary in light of **indications of likely adverse impacts** from business partners with fewer than 5 000 employees, and when this additional information cannot be obtained through other means.

#### ***Corporate due diligence on sustainability***

Directive (EU) 2024/1760 on corporate due diligence regarding sustainability, laying down rules concerning companies' obligations regarding adverse human rights impacts and adverse environmental impacts, should apply to (i) companies with an average of over 5 000 employees and a net worldwide turnover of over **EUR 1.5 billion** in the last financial year and (ii) companies with a net turnover of over EUR 1.5 billion in the Union in the financial year preceding the last financial year.

Companies would no longer be required to develop a climate change transition plan.

#### ***Responsibility and penalties***

Businesses should be liable for damages caused by breaches of due diligence obligations **under national law, rather than at the EU level**. The maximum fine level for offending companies would be at 5% of their global turnover. Moreover, to harmonise enforcement practices across the Union, the Commission, in collaboration with the Member States, should develop guidelines to assist supervisory authorities in determining the level of penalties.

#### ***Digital portal***

To facilitate compliance by companies with reporting and due diligence obligations under Union law, and to enhance the accessibility and usability of sustainability-related information, the Commission should establish a dedicated digital reporting portal. That portal should serve as a one-stop shop, providing companies, free of charge, with tailored access to templates, guidelines, reporting requirements, including voluntary tools, and information on funding and tendering opportunities.
