## Court of Auditors: appointment of a Romanian member

2025/0801(NLE) - 16/05/2025 - Final act

TITLE: Court of Auditors: appointment of a Romanian member.

PURPOSE: Appointment of a member of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision (EU) 2025/938 appointing a member of the Court of Auditors.

CONTENT: The term of office of Mr Viorel ŞTEFAN as member of the Court of Auditors is due to expire on 30 June 2025. Pursuant to this Decision, Mr Lucian ROMAŞCANU is hereby appointed as a member of the Court of Auditors, upon the proposal of Romania, for the period from 1 July 2025 to 30 June 2031.

PROCEDURAL CONTEXT: The appointment is made in accordance with Article 286(2) of the Treaty on the Functioning of the European Union, following a proposal from Romania and after consultation of the European Parliament.

ENTRY INTO FORCE: This Decision enters into force on the date of its adoption, 13 May 2025.

## Court of Auditors: appointment of a Romanian member

2025/0801(NLE) - 01/04/2025 - Text adopted by Parliament, 1st reading/single reading

The European Parliament decided by 437 votes to 128, with 92 abstentions, to give a **favourable opinion** on the Council's proposal to nominate **Lucian Romaşcanu** as a member of the Court of Auditors.

The Committee on Budgetary Control evaluated the proposed candidate's qualifications. As part of this evaluation, the committee received a curriculum vitae from the candidate and his responses to the written questionnaire sent to him. The committee then held a hearing with the candidate on 18 March 2025, during which he made an opening statement and then answered questions from committee members.
