## Court of Auditors: appointment of a Croatian member

2025/0802(NLE) - 22/05/2025 - Text adopted by Parliament, 1st reading/single reading

The European Parliament decided by 460 votes to 72, with 59 abstentions, to give a favourable opinion on the Council's proposal to appoint **Ivana Maletić** as Croatian member of the Court of Auditors.

The Committee on Budgetary Control Committee evaluated the proposed candidate's credentials. It then held a hearing with the candidate on 14 May 2025, during which she made an opening statement and then answered questions from committee members.
