Partial renewal of Members of the Court of Auditors - NL nominee

2025/0804(NLE) - 26/11/2025 - Final act

TITLE: Court of Auditors: appointment of a Dutch and a Luxembourgish member.

PURPOSE: Appointment of two members of the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision (EU) 2025/2421 appointing two members of the Court of Auditors.

CONTENT: The terms of office of Mr Stephanus Abraham BLOK (proposed by the Kingdom of the Netherlands) and Ms Joëlle ELVINGER (proposed by the Grand Duchy of Luxembourg) as members of the Court of Auditors are due to expire on 31 December 2025. Pursuant to this Decision, Mr Stephanus Abraham BLOK and Ms Joëlle ELVINGER are hereby appointed as members of the Court of Auditors for the period from 1 January 2026 to 31 December 2031.

PROCEDURAL CONTEXT: The appointment is made in accordance with Article 286(2) of the Treaty on the Functioning of the European Union, on the basis of proposals from the Kingdom of the Netherlands and the Grand Duchy of Luxembourg and after consultation of the European Parliament.

ENTRY INTO FORCE: This Decision enters into force on the date of its adoption, 13 November 2025.

Partial renewal of Members of the Court of Auditors - NL nominee

2025/0804(NLE) - 09/09/2025 - Text adopted by Parliament, 1st reading/single reading

The European Parliament decided by 462 votes to 129, with 25 abstentions, to give a favourable opinion on the Council's proposal to nominate **Stef Blok** (NL) as a member of the Court of Auditors.

The Committee on Budgetary Control assessed the proposed candidate's credentials. It then held a hearing with the candidate on 15 July 2025, during which the candidate made an opening statement and then answered questions from the committee members.
