TITLE:

Council of the European Union: appointment of a member of the Court of Auditors.

PURPOSE:

Appointment of a member of the Court of Auditors.

NON-LEGISLATIVE ACT:

Council Decision (EU) 2025/2528 appointing of a member of the Court of Auditors.

CONTENT:

- Mr Nikolaos MILIONIS is reappointed as a member of the Court of Auditors upon the proposal of the Hellenic Republic.

- The term of office is from 1 January 2026 to 31 December 2031.

PROCEDURAL CONTEXT:

The appointment is made pursuant to Article 286(2) of the Treaty on the Functioning of the European Union, following proposal by the Hellenic Republic and after consultation of the European Parliament.

ENTRY INTO FORCE:

The Decision enters into force on the date of its adoption, 8 December 2025.

Partial renewal of Members of the Court of Auditors - EL nominee

2025/0807(NLE) - 13/11/2025 - Text adopted by Parliament, 1st reading/single reading

The European Parliament decided by 523 votes to 41, with 64 abstentions, to deliver a favourable opinion on the Council's nomination of **Nikolaos Milionis** as a Member of the Court of Auditors.

By letter of 17 September 2025, the Council consulted Parliament on the nomination of Nikolaos Milionis as a Member of the Court of Auditors.

Parliament's Committee on Budgetary Control then proceeded to evaluate Nikolaos Milionis's credentials. In carrying out that evaluation, the committee received a curriculum vitae from Nikolaos Milionis, as well as the replies to the written questionnaire that he had been sent.

The committee subsequently held a hearing with Nikolaos Milionis on 5 November 2025, at which he made an opening statement and then answered questions put by the members of the committee.
