Partial renewal of Members of the Court of Auditors - FR nominee

2025/0808(NLE) - 13/11/2025 - Text adopted by Parliament, 1st reading/single reading

The European Parliament decided by 419 votes to 192, with 21 abstentions to deliver a favourable opinion on the Council's nomination of Pierre Moscovici as a Member of the Court of Auditors.

By letter of 29 September 2025, the Council consulted Parliament on the nomination of Pierre Moscovici as a Member of the Court of Auditors.

Parliament's Committee on Budgetary Control then proceeded to evaluate Pierre Moscovici's credentials. In carrying out that evaluation, the committee received a curriculum vitae from Pierre Moscovici, as well as the replies to the written questionnaire that he had been sent.

The committee subsequently held a hearing with Pierre Moscovici on 5 November 2025, at which he made an opening statement and then answered questions put by the members of the committee.

NON-LEGISLATIVE ACT:

Council Decision (EU) 2025/2528 appointing a member of the Court of Auditors.

CONTENT:

- Mr Pierre MOSCOVICI is appointed as a member of the Court of Auditors upon the proposal of the French Republic.
- The term of office of the member is from 1 January 2026 to 31 December 2031.

PROCEDURAL CONTEXT:

The appointment is made pursuant to Article 286(2) of the Treaty on the Functioning of the European Union, following proposals by the French Republic and after consultation of the European Parliament.

ENTRY INTO FORCE:

The Decision enters into force on the date of its adoption, 8 December 2025.
