TITLE: Council of the European Union: appointment of a member of the Court of Auditors.

PURPOSE: Appointment of a member to the Court of Auditors.

NON-LEGISLATIVE ACT: Council Decision (EU) 2026/422 appointing a member of the Court of Auditors.

CONTENT: The post of the member of the Court of Auditors is appointed upon the proposal from the Federal Republic of Germany. The term of office of that member is due to expire on 17 February 2026. Pursuant to this Decision, Mr Daniel CASPARY is appointed as a member of the Court of Auditors for the period from 1 March 2026 to 29 February 2032.

Partial renewal of Members of the Court of Auditors - DE nominee

The European Parliament decided by 411 votes to 206, with 25 abstentions, to deliver a **favourable opinion** on the nomination of **Daniel Caspary** as a Member of the Court of Auditors.

By letter of 24 October 2025, the Council consulted Parliament on the nomination of Daniel Caspary as a Member of the Court of Auditors.

Parliament's Committee on Budgetary Control then proceeded to evaluate Daniel Caspary's credentials. In carrying out that evaluation, the Committee received a curriculum vitae from Daniel Caspary, as well as the replies to the written questionnaire that he had been sent. Subsequently, it held a hearing with the candidate at which he made an opening statement and then answered questions put by the members of the committee.
