## Appointment of the Executive Director of the European Insurance and Occupational Pensions Authority (EIOPA)

2025/0904(NLE) - 17/12/2025 - Text adopted by Parliament, 1st reading/single reading

The European Parliament approved by 601 votes to 26, with 31 abstentions, the decision to appoint Damian Jaworski as Executive Director of the European Insurance and Occupational Pensions Authority (EIOPA).

The term of office of the current Executive Director of the European Insurance and Occupational Pensions Authority ends on 31 March 2026.

On 23 October 2025, the Board of Supervisors of the European Insurance and Occupational Pensions Authority, following an open selection procedure, proposed to appoint Damian Jaworski as Executive Director for a term of office of five years.

On 6 November 2025, the Committee on Economic and Monetary Affairs held a hearing with Damian Jaworski, at which he made an opening statement and then responded to questions from the members of the Committee.
